- **CITY PARKING TICKETS AND TOW** Parking in Battle parking lots without a parking permit is against City of Columbia Sec 14-551 & Sec 16-156 and violators will be arrested, ticketed and/or towed according to city laws at owner's expense.
- **CITY PARKING →** City tickets will also be given for parking in handicapped spots, non-parking areas, and parking in fire lanes (red or yellow curbs).
- **SCHOOL TICKETS WILL BE ISSUED FOR PARKING ILLEGALLY** in visitor spots, faculty assigned parking, or parking spots not assigned to you.
- **PARKING** at Battle is on a first come first serve basis.
- **A PARKING LOT ATTENDANT WILL BE AVAILABLE** at all times to take care of parking lot issues.
- **YOUR PARKING TAG MUST BE HANGING IN THE SAME VEHICLE(S)** indicated on your application on file in the main office.
- **IF YOU LOSE OR MISPLACE YOUR PARKING TAG REPLACEMENT TAGS** will cost \$10.
- **IF YOU NO LONGER WISH TO USE YOUR PARKING SPACE** you must inform the Main Office.
- **YOU CANNOT TRANSFER OR SELL YOUR TAG TO ANOTHER STUDENT.**
- **MULTIPLE TICKETS OF ANY KIND** will result in disciplinary consequences, loss of parking spot, having vehicle towed at owner's expense, etc.
- **LOSS OF PARKING PRIVILEGE:** Students who violate Battle High School policies regarding parking will face disciplinary consequences and possible fines.
- **OFF CAMPUS LUNCH:** Only **JUNIORS** and **SENIORS** are allowed to leave campus for lunch. If you are caught taking underclassmen off campus for lunch, disciplinary consequences will be handed down, up to losing your parking tag.
- **PLEASE NOTE THAT YOUR PARKING PRIVILEGE MAY BE REVOKED** (without refund) for the remainder of the school year in the following situations:
 - **ANY SUSPENSION related to drug and alcohol use, possession, or sale**
 - **Repeatedly Failing to display hangtag on mirror**
 - **Dangerous driving of ANY KIND on lot**
 - **Failure to adhere to ANY parking lot rule(s) listed on this page**
- **BATTLE HIGH SCHOOL IS NOT RESPONSIBLE FOR ANY damage incurred on the parking lot.** You are responsible for any damage you cause to another vehicle on the parking lot.
