## Call to Order

The meeting was called to order by President King at 7:30 a.m.

## Consideration of Agenda

The first matter of business was consideration of approval of the agenda for the June 20, 2013, meeting of the Board of Education. It was moved by Ms. Mees that the agenda be approved as presented. The second was by Mr. Whitt. The vote was 6 yes—0 no—1 absent.

## Update on 2013-14 Budget

Ms. Quinley presented a draft of the 2013-14 budget. The budget will be presented for consideration of approval at a special meeting of the Board of Education at 7:30 a.m. on Thursday, June 27, 2013, at the Administration Building, 1818 West Worley Street. The June 27 meeting will also serve as a public budget hearing.

## Office of Civil Rights (OCR) Training

Attorney James Thomeczek conducted a training session for the Board on Section 504 (equal rights, retaliation, discrimination, harassment, etc.) as required for a resolution to a recent OCR complaint.

## Consideration of Student Handbooks

Dr. Jolene Yoakum, Assistant Superintendent for Secondary Education, presented the 2013-14 elementary and secondary student handbooks for consideration of approval. It was moved by Mr. Sessions that the handbooks be approved. The second was by Mr. Whitt. The vote was 6 yes—0 no—1 absent.

## Consideration of Priority Schools Grant Application

Dr. Yoakum presented the Priority Schools grant application for Douglass High School, which was finalized and sent to the Missouri Department of Elementary and Secondary Education on June 14, 2013. It was moved by Mr. Sessions that the grant application be approved. The second was by Mr. Preis. The vote was 6 yes—0 no—1 absent.

## Dropout Rate Discussion

Dr. Belcher introduced Dr. Yoakum and facilitated a roundtable discussion about current district strategies on dropout prevention. Other participants included district administrators Ann Baker, Jeff Beiswinger, Tracey Conrad, Susan Emory, Eryca Neville, and Chip Sharp.
